In the event of my child taking up a place at Newton British School, I hereby undertake and agree that:

- 1. My child shall be subject to the applicable rules, regulations and discipline, as laid down by the Principal and designated representatives.
- 2. I give permission for photographs to be taken of my child at school, which may be published in the annual School Year Book.
- 3. I absolve Newton British School, its employees and its agents from any responsibility for:
 - The loss of valuables
 - Accidents or mishaps occasioned by participating in normal school life including, but not confined to, organised sports, gymnastics, informal play, practical and craft work.
 - The welfare and safety of my child outside the normal timetabled day and/or in activities supervised by members of staff of Newton British School. Newton British School will not be responsible for the safe delivery and collection of children to and/or from the school.
 - Any resulting accident or mishap should my child take unilateral action which is extracurricular and without permission.
- 4. I undertake to give the school timely written notice in the event of my child withdrawing from Newton British School, by completing a Notice of Withdrawal Form which is available from Administration. I understand that it is mandatory to attend an exit meeting with the school Principal prior to withdrawal.
- 5. I will pay the required Registration Fee in order to secure the place which has been offered. This payment cannot under any circumstances be refunded. I understand that if I remove my child from the school in order to attend another school, I will again be liable for the Registration Fee if the child re-enters Newton British School at a later date.
- 6. I will pay all Tuition Fees in advance, prior to the commencement of the term to which they apply, and I realise that there will be no reduction of fees if my child is absent for part of any term.

- 7. Fees paid in advance will only be refunded under the following circumstances:
 - 90% refund at least 7 calendar days written notice is given before the start of the term that your child no longer requires a place.
 - 50% refund after 7 calendar days written notice is given but before the first day of term.
 - No refunds will be made if notification is given after commencement of any term.

Application Procedure

Guidance notes for Parents

- 1. Complete this form and return it to the School office together with:
 - Passport photographs x3
 - Copy of child's passport and residence visa
 - Reports from previous school in English
 - Copy of Parents' passports and Qatar ID cards (both father and mother)
 - Copy of child's immunisation record
 - Employment certificate of the Sponsor (father/mother)
- 2. Applicants applying to enter Newton British School are required to successfully complete an Entrance Test appropriate to the child's year group. This test is based on Literacy and Numeracy.
 - A **non-refundable** test fee must be paid before a test date will be scheduled (credit or debit card payment only).
 - On the date of the scheduled test, you should bring your receipt as proof of payment.
 - Should you cancel the scheduled test and/or your application to the school, the test fee will not be refunded.
 - You will be advised by email and/or telephonically whether the school can offer your child a place.
- 3. To confirm your acceptance of the offer, you must visit the School Office to pay the Registration Fee. Failure to pay the registration fee by the date to be specified will result in the place being offered to an alternative child.
